Good afternoon,

The use of the wreath and candles during Advent are a longstanding Catholic tradition that was originally adopted by Christians in the Middle Ages as part of their spiritual preparation for Christmas.

The wreath and candles are full of symbolism tied to the Christmas season. The wreath itself, which is made of various evergreens, signifies continuous life. The circle of the wreath, which has no beginning or end, symbolizes the eternity of God, the immortality of the soul, and the everlasting life we find in Christ.

Even the individual evergreens that make up the wreath have their own meanings. The laurel signifies victory over persecution and suffering. The pine, holly, and yew signify immortality and the cedar signifies strength and healing. The pinecones that decorate the wreath symbolize life and resurrection. The wreath as a whole is meant to remind us of both the immortality of our souls and God's promise of everlasting life to us through Christ.

The third Sunday of Advent is Gaudete Sunday and is meant to remind us of the joy that the world experienced at the birth of Jesus, as well as the joy that the faithful have reached the midpoint of Advent. The third candle, which is pink and symbolizes joy, will be lit. It is called the "Shepard's Candle," and is pink because rose is a liturgical colour for joy.

Whatever you are doing this Sunday, we hope that it is filled with joy, love and the hope of a wonderful Christmas to come.

Class Parties

Each class will have a party on the last day of term (Wednesday 20th December). The children are invited to bring a named plate of food to eat at lunch time. There will be no food provided by Willoughby Foods Ltd on this day. Willoughby Foods packed lunches will be available for those children entitled to free school meals that have completed the form or contacted the office.

Reverse Advent Calendar

We are collecting for Agape Food Bank again this year. If you feel able to donate, a cardboard box will be available every day in December (until Tuesday 19th December) in each classroom for your child to add one item during that time. These items will be donated to Agape Food Bank. Donation suggestions: Christmas-specific non-perishable food items, Christmas crackers, colouring books, stationery, tinned fruit or veg, potatoes, pasta, rice, soup, rice pudding, custard, sponge puddings, toiletries. Over the last few years there has been an ongoing problem in Lincolnshire with malicious communications. It is one of the top 5 crimes in which 14-16 year olds have received a criminal conviction for. Online behaviour is something we talk regularly to children and young people about within our online safety sessions and we want to also make

sure parents are aware of these laws and the potential consequences our online behaviour can have in the real world, for our children's futures. We are aware of the heightened financial pressures that many of you are facing at the moment and as a staff, we wish to emphasise that we do not expect 'thank you' gifts from children/parents. Should you wish to say 'thank you', we always appreciate homemade cards, letters and gifts (items of food must be clearly labelled for allergens and wrapped securely) or a spoken word of 'thank you' (kind words mean a lot!). If you wish to give any cards/gifts, these can be dropped off at the school office, clearly labelled with staff and child's name, rather than handing them out to class staff to avoid those families who can't afford gifts from feeling uncomfortable. 

Laws about online behaviour

There are a number of laws that apply to behaviour online.

(2) Is cyberbullying or trolling against. the law?

Although bullying, cyberbullying or trolling are not specific criminal offences in UK law, there are criminal laws that can apply in terms of harassment or threatening behaviour. For example should you receive threatening, obscene or repeated messages and fear for your safety, this is against the law and you should contact the police. Context is taken into consideration and the police will determine the response on a case by case basis.

Some of the laws below are relevant:

Communications Act 2003: This Act covers all forms and types of public communication. With regards to comments online, it covers the sending of grossly offensive, obscene, menacing or indecent communications and any communication that causes needless anxiety or contains false accusation.

Protection from Harassment Act 1997: This Act covers any form of harassment that has occurred 'repeatedly'; in this instance, 'repeatedly' means on one or more occasions.

The Malicious Communications Act 1988: This Act covers the sending of grossly offensive or threatening letters, electronic communications or any other form of message with the intention of causing harm, distress or anxiety.

Equality Act 2010: This Act states that it is against the law to discriminate against anyone on the ground of protected characteristics. These include disability, gender reassignment (when a person undergoes a process, or part of a process - social or medical - for the purpose of reassigning their sex), race (including colour, nationality, ethnic or national origin), religion or belief, sex and sexual orientation.

Hate crimes and hate speech if you commit a crime against someone because of their religion, race, sexual orientation or disability, this is classified as a hate crime. Hate speech is defined as expressions of hatred and threats directed at a person or a group of people on account of that person's colour, race, nationality, ethnic or national origin, religion or sexual orientation. Hate crimes should be reported to True Vision www.report-it.org.uk



What other laws affect the online space?

The Computer Misuse Act 1990 says you can't impersonate or steal someone else's identity online. This means that writing a status on social media pretending to be your friend is technically against the law

The Protection of Children Act 1978 and the Criminal Justice Act 1988 says that indecent images (naked pictures) of children under the age of 18 are illegal.

Section 33 of the Criminal Justice and Courts Act 2015 refers to the new offence dealing with Revenge Pornography. This is a law relating to images of adults (ie over 18s), making it illegal to share or make public sexually explicit images of someone else, without their consent, with the intent to cause distress.
